

Rigid Global Buildings PRECOATED SPECTRALITE 3000 PANEL PRECOATED 70% FLUOROPOLYMER PANEL LIMITED THIRTY (30) YEAR WARRANTY

Rigid Global Buildings, hereinafter referred to as RIGID, is pleased to extend the following limited warranty: Our SPECTRALITE 3000 PAINT SYSTEM.

COVERAGE:

This limited warranty applies only to goods used on wood frame buildings and on architectural, commercial, pre-engineered or residential metal buildings, which are installed in the United States, Canada and Mexico.

TERMS:

RIGID warrants that the goods covered by this warranty will resist natural weathering to the extent that they will conform to the performance standards listed below during a period of 30 years after coating for film integrity and a period of 30 years after coating for both chalking and color change, provided that all conditions of this warranty are first met. Provisions (1) through (3) below apply to buildings installed north of the 16 degrees parallel obtained in the northern hemisphere. Only provision (1) applies to buildings installed south of this latitude:

- 1. SPECTRALITE 3000 will not peel, crack, check, or flake to an extent that is apparent to an ordinary outdoor visual observation, and
- Vertical installation will not change color more than 7 NBS (Hunter) units, and non-vertical installations will not change color more than 7 NBS (Hunter) units following field installation. Color measurements are to be made per ASTIND 2244 and only on clean surfaces after removing surface deposits and chalk per ASTM D 3964; and
- Vertical installations will not chalk more than a number 8 rating, and con-vertical installations will not chalk more than a number 6 rating, when
 measured per ASTM D-4214, Method A.

This warranty applies only to panels efected in the Continental United States (including Alaska) and Canada, which have been exposed to normal weather and atmospheric conditions. This warranty is limited to aforementioned sefects or failures caused by acts of God, falling objects, external forces, explosion, fire, riots, civil commotions, acts of war, radiation or narmful gas or fumes, excessive salt atmosphere and regardless of roof or sidewall pitch, installation must provide for proper drainage so as not to hold any water and provide sufficient ventilation for structure not totally enclosed.

RIGID further agrees to replace, repair, or repaint, at its option and cost, any effected panels and reserve the right to approve and / or negotiate contracts for such painting or replacement. Any repainted or replacement panel supplied as provided herein shall be subject to warranty only for the remainder of the period applicable to the panel originally purchased. The limit of this warranty shall be the cost of repainting, repairing, or replacing the effected panels. The obligations under this warranty shall not arise due to failure to remove debris or other accumulations of foreign substances or material s from the panels.

THIS WARRANTY IS NON-TRANSFERRABLE AND NON-ASSIGNABLE BEYOND THE ORIGINAL BUILDING OWNER. THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, WHICH EXTEND BEYOND THE DESCRIPTION AS STATED HEREIN INCLUDING ANY WARRANTIES OF MERCHANTIBILITY OR FITNESS OF PURPOSE. RIGID SHALL NOT BE RESPONSIBLE FOR ANY INDIRECT OR CONSEQUENTIAL DAMAGES (SUCH AS DAMAGES TO THE CONTENTS OR FURNISHINGS OF ANY BUILDING) OR ANY LOSS OF ANY KIND.


RIGID warrantees only that its panels and trims are free from defects in material and workmanship on the date of shipment from its plant. If RIGID' examination proves the panels and trims to be defective as herein defined, replacement shipping shall be prepaid by RIGID, and return shipment of original material shall be freight collect to the consignee. Title to any replaced material shall pass to RIGID.

This warranty does not cover failures resulting from edge corrosion or if failure is caused by failure of the metal substrate or conversion coating material or in the application of RIGID material, nor does it cover minute fracturing which may occur in proper fabrication of the building parts. This warranty is conditional upon payment in full to RIGID for materials furnished and proper storage of materials prior to installation.

All claims filed under the provisions of this warranty must be presented by the customer to RIGID in writing during the warranty period and not more than thirty (30) days after detection of any apparent defects, delivered by Registered or Certified Mail and referencing RIGID's invoice and date of shipment.

This warranty shall remain in full force and effect during its term until terminated by giving thirty (30) days written notice. No termination shall affect the rights accrued prior to termination.

This is our complete Warranty. It sets out all our obligations regarding the Spectralite 3000 polyester coatings. It is only for the benefit of the original buyer and is non assignable. It cannot be changed by such things as your purchase order forms or any other forms.
